Indemnity

Please note: in this document the term "**Indemnitees**" includes, but is not limited to Mashatu Nature Reserve (Pty) Ltd commonly known as Mashatu Game Reserve ("**Mashatu**"), and Tuli Safari Lodge (Botswana) (Pty) Ltd commonly known as Tuli Safari Lodge Mashatu ("**Tuli**"), their owners, shareholders, directors, employees, contractors, service providers, concessionaires, syndicates and any other person or entity connected (directly or indirectly) with the business of Mashatu and/or Tuli; and other guests of Mashatu and/or Tuli.

By signing this document I acknowledge that I am fully aware of, and appreciate, the dangers and risks ("**Risks**") associated with:

- 1) wilderness areas, open water, wildlife reserves, game lodges, surrounding areas and undeveloped or partially developed areas, including (but not limited to):
 - a) the presence of wild and dangerous animals;
 - b) the prevalence of communicable, tropical and other diseases and similar health hazards;
 - c) unpredictable and extreme weather conditions;
 - d) dangerous terrain and border crossings (including the Cable Car at Pont Drift);
 - e) heavy or dangerous machinery, such as motor vehicles and boats;
 - f) acts of terrorism, civil unrest, crime and pandemics;
 - g) the unavailability of reliable electricity and communications;
 - h) other problems associated with limited or unavailable healthcare, safety and security services and air transportation;
 - i) generally, any risk connected (directly or indirectly) with my stay in Mashatu and/or Tuli.
- 2) all safari, outdoor, and related activities ("**Activities**"), including (but not limited to):
 - a) animal viewing, off-road and on-road driving through various terrains and jurisdictions in a wilderness area;
 - b) swimming, boating and other water-based activities;
 - c) hiking, walking, running, cycling, drones, filming, photography and horse riding;
 - d) generally, any activity connected (directly or indirectly) with my stay in Mashatu and/or Tuli, including any travel to and from camps, lodges, communities and borders.

I confirm that:

1. I freely assume full responsibility for any Risks; and I make use of all facilities and undertake all Activities, whether on the premises of Mashatu and/or Tuli. or not, entirely at my own risk.
2. I fully understand and accept that my visit, stay, participation in Activities, tours and excursions of any nature whatsoever shall be voluntary and undertaken at my own risk.
3. I am aware that I will be participating in the Activities in and around Mashatu and/or Tuli which are inherently dangerous, including but not limited to, the viewing of game and wildlife on foot and from open and closed vehicles.
4. I am aware of the Risks and any and all inherent and real dangers that are associated with game reserves and / or game lodges, arising from the presence of wild and dangerous animals, reptiles, birds and insects and the real risk of bodily harm, sickness, personal injury, death and / or damage to property which may arise as a result of an encounter with the aforementioned creatures, and / or the particular circumstances prevailing on a game reserve or a game reserve environment for anyone, that cannot be eliminated.
5. I am personally responsible for my health and safety during my visit, stay, participation in Activities, tours and excursions of any nature whatsoever at Mashatu and/or Tuli premises, and for the health and safety of those accompanying me.
6. I will comply with all Mashatu and/or Tuli policies and rules including but not limited to all Lodge protocols, guidelines, signage, and procedures (including those related to Covid-19 and / or any other contagious or infectious diseases).
7. I am aware the Mashatu and/or Tuli premises are open to the public and recognise that I am at a higher risk of contracting any infectious or contagious disease including but not limited to Covid-19.
8. I hereby waive and abandon any claim(s), which I, my dependants, relatives, guests, or executors may have, at any time, against the Indemnitees arising out of, or in connection with, or as a result of: -
 - 8.1. any loss of or damage to property owned by me, and/or
 - 8.2. my death, or injury to myself, in the course of my visit or stay, or as a consequence of my visit or stay, participation in Activities, tours, and excursions of any nature whatsoever.
9. I hereby indemnify, hold harmless and absolve the Indemnitees, from any or all claims whatsoever which may arise in connection with, or as a result of: -
 - 9.1. any loss of or damage to property owned by any of my dependants, relatives or guests; and/or

9.2. the death of or injury to any of my dependants, relatives or guests, in the course of their visit or stay, or as a consequence of their visit or stay, participation in Activities, tours and excursions of any nature whatsoever.

10. I waive any and all claims of whatsoever cause or nature howsoever arising against the Indemnitees, which I might have arising out of any harm, injury, death or loss suffered during my visit, stay, participation in Activities, tours and excursions at Mashatu and/or Tuli whether arising from an act of commission or omission and/or negligence on the part of the Indemnitees.
11. I undertake to indemnify and hold harmless and free, the Indemnitees from any and all claims of whatsoever cause or nature which may be made by my spouse, common-law-wife/husband, my children, whether minor or adult, relatives and/or any other dependents who suffer any damages, including but not limited to personal injury or death, loss of support or any other loss related directly or indirectly to such persons visit, stay, participation in Activities, tours and excursions, at Mashatu and/or Tuli arising from any cause whatsoever (including but not limited to any act of commission or omission and/or from the negligence on the part of the Indemnitees).
12. I am aware that this document has legal consequences and that if I do not understand its contents or implications; I should discuss same with my legal representatives before signing it. I understand this document and appreciate its implications.

I understand that I am required to read carefully and sign this Indemnity and Waiver from Mashatu and/or Tuli. I accept that Mashatu and/or Tuli will assist or advise me, to the best of their ability, with pertinent information in respect of my stay at Mashatu and/or Tuli but that it is my responsibility to ensure that passports, visas, travel permits, health certificates, inoculations, or other documentation required are obtained, current and in order. Mashatu and/or Tuli also advised and encouraged me to obtain comprehensive travel insurance cover which I understand is commercially available including accidental death and disability cover, major medical cover, emergency medical evacuation cover, loss of personal effects cover and trip cancellation cover.

Furthermore, I am aware that adventure travel, whether in civilised or remote areas, by plane, vehicle, bicycle, cable car, other conveyance, on horseback or on foot, contains inherent risks of illness, injury, death, or loss and damage of property, which may be caused by negligence of others, forces of nature, wild animals and or other causes known or unknown. I recognise that such risks may be present at any time before, during and after the trip that I am participating in under the arrangements of Mashatu and/or Tuli and/or their agents, associates, lessees or concessionaires. I am also aware that medical services or facilities may not be readily available during the time I am participating in this trip.

I acknowledge that this indemnity and waiver applies to any facilities, camps, lodges, premises or roads/pathways which may form part of or be under the control of Mashatu and/or Tuli which I, my spouse, partner, children or any persons accompanying me may visit or stay at. No amendment or cancellation of the terms contained in this document shall be valid or binding unless reduced to writing and signed by persons duly authorised to represent the parties.

I acknowledge and agree that any contract between me and any of the Indemnitees, including this indemnity, shall be governed according to the laws of Botswana and that the courts in Botswana shall have exclusive jurisdiction to hear and determine all actions. In the event of minor children (i.e., younger than 18 years of age) visiting Mashatu and/or Tuli, by completing and signing the below table, I confirm I am the parent / legal guardian of the following minor(s) and have read the terms and conditions of this indemnity, and acknowledge and fully consent on behalf of the minor(s) listed below, to be bound thereby.
